

Privacy Policy for the Stakeholder Sustainability Survey 2024

This privacy policy concerns the processing of personal data collected by Ziegler Holding GmbH (hereinafter "Ziegler") and its affiliated companies as part of the stakeholder survey via the platform of cubemos. The following describes how Ziegler processes personal data and protects privacy.

1. Who is responsible for the processing of personal data?

3. What personal data is processed?

Due to the anonymous implementation of the survey, this point is not applicable, as no personal data is collected.

4. What technical access data is processed during the survey with MS Forms?

IP address:

The way the internet works means that data is transmitted from your browser to a web server every time you call up any internet page. This includes, for example, data about the software used (e.g. browser, operating system), about the use of a website (e.g. name of the domain/page visited, start and duration of the visit) and the IP address permanently or temporarily assigned to your computer by the network operator.

If IP addresses are stored, they may, under certain circumstances, enable the subsequent assignment of data to the Internet user's computer. For this reason, IP addresses are generally not stored in this survey, not even temporarily or partially.

5. From which sources does the personal data originate?

We obtain the personal data from personal contacts (business cards, e-mail contact), from publicly accessible data sources (in particular homepages of associations, institutions, organisations) and from external providers.

6. How long will the personal data be stored?

We store the data for as long as they are up to date (data is checked annually to ensure that it is up to date), unless the stakeholder objects to the further processing of his or her data.

7. For what purposes is the personal data processed?

We process personal data for the following purposes:

- to be able to provide stakeholders with information from Ziegler that is relevant to them in their function (e.g. the Sustainability Report),
- for invitations to various dialogue formats
- for conducting our annual online stakeholder survey.

8. What is the legal basis for processing personal data?

We process the personal data on the basis of our legitimate interest pursuant to Art. 6 para. 1 lit. f) DSGVO. Our legitimate interest in processing the data is based on being able to contact stakeholders relevant to us in order to obtain information and engage in dialogue.

9. Who are the recipients of the personal data?

Access to personal data is strictly limited internally to the employees whose area of responsibility includes stakeholder management at Ziegler. Data will not be transferred to third parties.

10. What rights can you assert?

The following rights can be asserted in relation to the processing of personal data:

The right to information, correction, deletion, restriction of processing, objection to processing and the right to data portability.
